Purpose

The University requires your correct SSN or TIN to file certain information returns with the Internal Revenue Service (IRS) and to provide you a Form 1098-T Tuition Statement. For students, this will be your social security number (SSN) or, if you are not eligible to obtain an SSN, your individual taxpayer identification number (ITIN). Please note that if you are a non-resident alien and do not have income that is subject to tax, you are not required to supply this information and you should indicate this by checking the appropriate box on the Substitute Form W-9S.

Form 1098-T contains information about qualified tuition and other related expenses to help determine whether you, or the person who can claim you as a dependent, may take either the tuition and fees deduction or claim a deduction credit to reduce Federal income tax. For more information, see IRS Publication 970, Tax Benefits for Higher Education by visiting www.irs.gov.

Penalties

Under Federal law, you are required to provide the requested information. Failure to provide your correct SSN or ITIN to the University of South Carolina, could result in a penalty of \$50.00 under Internal Revenue Code (IRC) 6723 from the IRS.

Information

Your name and mailing address should match that used by the Social Security Administration or Internal Revenue Service.

If you do not have an SSN or ITIN, you may apply for one and fill out and return this form when you receive it.
