#### **Announcements**

- o The ASC will begin dedicated exam prep sessions for NURS 216 in October. These events are coordinated with faculty and reflect newly updated course content.
- o The ASC will be closed on Thursday October 9<sup>th</sup> for fall break.

#### **Recent and Upcoming Events Overview**

In September, the ASC hosted the library's two **fandom talks**. Dr. Evan Nooe presented his research on Disney Studies on 9/17, and Dr. Dana Lawrence presented her research on literary tourism on 9/30. These talks are coordinated by library faculty, but we are pleased to host them in the ASC Studio. We will also host future talks on 10/14, 10/28, and 11/11.

We held two **new supplemental instructional sessions** for students in Nursing 312 and 324 in September and anticipate having three in October. This program, provides important support for difficult and intensive upper division courses in the nursing program, filling a gap in local student success services compared to the Columbia campus. Nine students attended the first session on 9/5, and eight attended the second on 9/26/25.

For the first time in September, the ASC was able to hold **two events simultaneously** thanks to our newly refurbished and furnished room, ML 221 (name TBD). On Tuesday, Sept. 20<sup>th</sup>, we hosted Dr. Lawrence's fandom talk at the same time as our regularly scheduled Math Lab service. Having expanded facilities will ensure we can continue to hold ongoing tutoring-oriented studio services while also offering enrichment activities.

# **Summary of Tutoring Data**

Year-to-year trends: In September, we served 63 students through 106 sessions, representing strong support for the USCL student body. However, lower-than-usual demand for Math 111/111i, a sharp decline in demand for BIOL 243, and a reduction in appointment availability created challenges through the second half of the month. This resulted in somewhat lower totals compared to previous years. We are working to drive demand with promotion and outreach and look to bounce back in October.

**Session distribution trends:** Distribution of services was atypical in September. Studio services saw higher-than-average attendance, and studio services were a higher proportion of overall use. We are also pleased that athlete and dual-enrollment visits climbed substantially. Course distributions are also atypical, with a substantial tilt toward upper-division and away from lower-division courses in Math and very little demand for BIOL 243, which is usually a big driver of student visits.



## 1) Open Enrollment

Open Enrollment for 2026 benefits begins October 1, 2025, and ends on October 31, 2025. Any changes you make during Open Enrollment take effect January 1, 2026. Life insurance changes are effective January 1, 2026, or when MetLife approves coverage, whichever is later.

If you are satisfied with your current coverage, no action is required. Your current insurance coverage will continue in 2026.

However, you must re-enroll in Medical Spending, Limited-use Medical Spending, and Dependent Care Spending accounts each year.

#### **Changes Allowed During 2025 Open Enrollment**

- Enroll in, change, or cancel **health** coverage for yourself and/or eligible dependents.
- Enroll in, change, or cancel **dental** coverage for yourself and/or eligible dependents.
  - (Changes to existing dental coverage can be made during open enrollment only in odd-numbered years. If you do not make changes this year, your next opportunity to make a change will be October 2027.)
- Enroll in or cancel the **State Vision Plan** for yourself and/or your eligible dependents.
- Enroll in or increase **Optional Life Insurance** coverage (up to \$50,000 without medical evidence; more than \$50,000 requires medical evidence).
- Enroll in or increase **Dependent Life-Spouse** coverage (medical evidence required).
- Decrease or cancel Optional Life and Dependent Life-Spouse Insurance Coverage.
- Enroll in or cancel **Dependent Life-Child** Insurance coverage.
- Apply for **Supplementary Long-Term Disability (SLTD)** coverage (medical evidence required).
- Change your Supplementary Long-Term Disability (SLTD) waiting period (180 to 90 days with medical evidence, or 90 to 180 days without medical evidence.
- Cancel your Supplementary Long-Term Disability (SLTD) coverage.
- Enroll in or drop the **Pretax Group Insurance Premium** feature.
- Enroll in or re-enroll in **flexible spending accounts (FSAs)** (Medical Spending Account, Limited-use Medical Spending Account, or a Dependent Care Spending Account). You can carry over up to \$660 of unused Medical Spending Account and Limited-use Medical Spending Account funds into the next plan year.

• Enroll in, change, or stop contributions for a **Health Savings Account (HSA)**. (available only to Savings Plan members).

# 2) New Pharmacy Benefits Manager Effective January 1, 2026

The South Carolina Public Employee Benefit Authority (PEBA) has announced that CVS Caremark will replace Express Scripts as the pharmacy benefits manager for the State Health Plan, effective January 1, 2026.

To ensure a smooth transition:

- New prescription benefits ID cards will be mailed to all subscribers, including Medicare-eligible members, prior to December 31, 2025.
- Once received, please present your new ID card at your network pharmacy to continue filling prescriptions without interruption.

Student-Athletes continue to be encouraged to work with their professors regarding any missed classes due to games. Reminder, student-athletes should not be missing any classes due to practice.



#### **OPPORTUNITY SCHOLARS PROGRAM**

#### **Funding Status**

- After extended delays at the federal level, we received our long-awaited Grant Award Notification (GAN) for a new five-year grant **totaling over \$1.5 million** on September 26. This grant award will be through the period ending August 31, 2030.
- A huge thank you to the members who served on the Proposal Development Committee back in 2024 for making this award possible: **Dr. Shemsi Alhaddad**; **Mark Ammons**; **Dr. Courtney Catledge**; **Ken Cole**; **Shana Dry**; **Dr. Pat Lawrence**; **Dr. Todd Lekan**; **McKenzie Lemhouse**; **Dr. Kim Richardson**; **Lauren Thomas**; and **Matt Williamson**. We also greatly appreciate **Dr. Maggie Aziz** (USC Union), **Amy Hood**, **Dr. Tamika Lewis**, **Asheley Schreyer**, **Aubrey Stewart**, and **Chuck Wright** (USC Sumter) for their invaluable contributions to this process.

#### **Enrollment Update**

- We ended our FY25 project year on September 30, having served 166 total students from low-income and first-generation (LIFG) backgrounds, as well as students with disabilities. We are required to serve a minimum of 165 eligible students each year.
- We were able to successfully recruit and serve an additional 27 eligible students during the final month of the grant cycle. Special thanks to CoSonja Allen and Andrea Campbell for leading this incredibly successful recruitment effort.

#### **LEGISLATIVE UPDATES**

# Notes Concerning the Government Shutdown

- Federal TRiO Programs are forward funded, so all our current operating funds are already secured. These funds for 2025-26 were included in the FY25 continuing resolution (CR) passed back in March 2025. In our most recent GANs, these funds are secured and committed to the University for the 2025-26 program year. Therefore, our Office of Federal TRiO Programs may continue operating as usual.
- Our G5 drawdown platform will continue to operate. Projects may continue to draw down funds as they usually do.
- Non-essential employees in the TRiO division of the Department of Education (ED) will be furloughed. It is recognized that the status of most federal government employees remains uncertain as the Office of Management and Budget (OMB) has advised federal agencies to develop plans to reduce their workforce if a shutdown were to occur permanently. However, recent reports indicate that most federal agencies intend to move forward with their typical shutdown plans for placing employees on furlough (as opposed to permanent layoffs). At a minimum, we should expect most ED staff to be furloughed during the government shutdown. That is, we won't be able to reach ED employees during the shutdown.

# PCCFS Rights & Responsibilities Committee Report to USCL Faculty Organization October 3, 2025

- The committee met on Friday, September 19, 2025.
- USCL Representatives: Claudia Heinemann-Priest, Dana Lawrence, Brittany Taylor-Driggers

The PCCFS Rights & Responsibilities committee has been asked to work on the following questions related to the faculty Tenure and Promotion and Instructor rank processes:

# 1. T&P File Length and Guidance

The length of T&P files is growing, with no clear limits in the current manual, making the review process increasingly challenging. Columbia's files, for comparison, are limited to 15 double-spaced pages.

The committee is considering whether to propose specific length requirements and to develop more standardized guidance for file preparation to ensure comparability and manageability for the T&P committee.

# 2. New Course Evaluation System (Explorance Blue)

The shift to the Explorance Blue course evaluation system presents a challenge for T&P committees due to anticipated changes in the quantitative and qualitative data provided.

The committee is discussing how candidates and T&P committees should handle this shift when preparing and evaluating files.

# 3. Evaluation System Questions

The R&R committee has been asked to propose two PC-specific questions for the Explorance Blue evaluations that will be included in the T&P evaluation.

Instructors may also choose two optional questions for surveying, but these are not part of the T&P evaluation.

## 4. Teaching Summary Clarifications for Tenure Files

There is significant variation in the quality and format of teaching summaries in tenure files, despite manual-dictated length limits which are not consistently followed.

The committee discussed standardizing the teaching summary format through official guidance and potentially offering a writing workshop for those who prepare these summaries.

## 5. Senior and Principal Instructor Definitions and Processes

The motion regarding new Instructor ranks from last year was not approved by the Provost, who requested revisions—specifically, the Provost's concerns center on the following:

- reducing the time-in-rank for Senior Instructor promotion (to five years)
- establishing a new promotional tier (Principal Instructor/Lecturer)
- revising the promotion dossier requirements to focus on professional growth instead of mandatory annual reviews
- ensuring consistent appointment terms for professional-track faculty
- eliminating outdated "non-tenure track" terminology.

Many of these items come from recent changes put forth by Columbia Faculty Senate, of which the PCC R&R committee was unaware. The committee supports a three-level ranking system for Instructors (Senior and Principal Instructor ranks, where Principal Instructor is a rank at Columbia).

The committee plans to work with senate leadership on manual language. We need to confirm that administration on each campus agrees with and has funding for these positions and associated raises.

In addition to the charges coming from PCCFS Executive Committee, R&R discussed issues of Academic Freedom and Free Speech, which falls within the committee's scope concerning "issues regarding faculty relations with administration and students" (*PCCFM* 96).

There is a lack of clarity regarding how current **Academic Freedom and Free Speech policies** are being upheld. The committee posed the following question:

"Will there be a forthcoming statement about Academic Freedom and Free Speech from the Palmetto College Administration. Specifically, we are interested in clarification about PC procedures for the defense of academic freedom and free speech."

Thus far, there has been no response.

# Report of the Free Expression and Academic Freedom Committee

#### **Background**

Two recent incidents have caused concern over free expression and academic freedom among members of the USCL community.

First, a professor at Texas A&M University had a course canceled before it was complete after a student filmed a video of a classroom lecture on gender. The video went viral and was used by public figures in Texas to pressure the university for the professor's termination. After initially appearing to defend the instructor's academic freedom to teach this material, the university did terminate her amid persistent pressure from state leaders. Two deans who had initially decided to forego any action against the professor were also removed from administrative roles. Subsequent to that, the system president also resigned.

Second, following the assassination of Charlie Kirk, there has been intense pressure from political figures and members of the public to punish individuals for responses to the murder on social media. The targeted responses include posts that could be perceived as celebrations of violence or callousness toward the victims of violence, but some individuals have been targeted for comments that are merely critical of Mr. Kirk's politics or his rhetoric. Reports indicate this has led to dozens of terminations of university employees across the nation.<sup>2</sup> These include several cases around the state of South Carolina, including both faculty and staff at Clemson University.<sup>3</sup> In one notable case, an instructor at USC Union was relieved of teaching duties after posting criticism of a state representative who proposed renaming a road after Mr. Kirk. Similarly, a teacher and coach at Buford High School in Lancaster County was removed from duty pending an administrative investigation after significant public outrage at his posts condemning Mr. Kirk.<sup>4</sup> In both cases the language used was vulgar, but the posts do not appear to condone violence. Additionally, while it is a misdemeanor in South Carolina to terminate someone's employment because of their political beliefs,<sup>5</sup> the SC Attorney General has issued guidance indicating he does not think it proper to prosecute employers in these cases.<sup>6</sup>

These actions have left members of the USCL community unsure of their ability to teach as their expertise and judgement direct them and uncertain how their private speech may affect their employment.

#### Assessment

Experts across the ideological spectrum generally agree that the free-speech environment in the U.S. today is unhealthy, with the above terminations representative of a trend toward restrictions on disfavored speech.<sup>7</sup> This is an especially tenuous time for public-sector employees, particularly those affiliated with universities.<sup>8</sup> It is unclear whether recent pressure from politicians, donors, activists, and members of the public will be short-lived or persistent, but in either case, recent events have demonstrated how vulnerable speech rights and job protections can be.

Faculty and staff should be aware that their political speech and advocacy may result in negative repercussions ranging from doxing and unwanted media attention through adverse employment actions up to and including termination. This applies even to speech that is nonviolent or that normally would be protected by the First Amendment. The SC Attorney General's guidance further suggests that the burden to remedy wrongful termination or the infringement of rights will fall to affected individuals.

## Advice for Faculty and Staff

With respect to academic freedom: teaching material that may be controversial brings certain risks, and it is advisable to ensure that such work is undertaken thoughtfully. Faculty are in the best position to tackle controversy when squarely within their area of expertise, since expertise is a core component of academic freedom. It is a good idea to document the curricular justification for such material, including sharing it with students in advance. Faculty may want to consider the propriety of offering students alternative assignments. USCL's administration has indicated their support for academic freedom, but speaking in advance with the academic dean will help avoid potential issues and may help allay concerns.

With respect to free expression: faculty and staff should be aware that their online presence, including but not limited to social media, can be widely circulated in ways that strip it of context or distort its meaning. Strong use of restrictive privacy settings is encouraged, though this does not guarantee safety. As a committee, we regretfully acknowledge that in this climate some faculty and staff will opt to remain silent rather than exercising their civic rights and duties to comment on matters of public concern. Those without strong job protections may want to take special care.

For those who do want to engage in first-amendment activities, it is recommended that you do so in respectful and professional terms, emphasizing issues rather than individuals. Doing so is not a

guarantee against unwanted attention but may make speech easier to defend while eliminating a pretext for adverse actions. It is also important to indicate that your views are yours alone and do not represent the institution.

#### Relevant Policies and Resources

Faculty and staff may want to consult relevant Human Resources policies to understand what protections they have or do not have, as well as grievance procedures that might apply. Such policies are generally governed by employee handbooks but HR 1.57 (on separations) and HR 1.39 (on disciplinary procedures) are also relevant. Individuals may want to know that states do have some leeway to restrict the speech of employees in the interest of maintaining efficient government operations, as outlined in *Pickering v. Board of Education*. Description of the interest of maintaining efficient government operations, as outlined in *Pickering v. Board of Education*.

The university community's speech environment is also informed by two policies that were recently affirmed by the Board of Trustees. One is UNIV 6.00, which governs the conditions under which speech may be regulated on system campuses.<sup>12</sup> The other is the Chicago Principles, a statement outlining a commitment to diversity of viewpoints and toleration of speech even when its content or delivery is offensive.<sup>13</sup>

Finally, employees should know that there are resources available to them both before and after an incident occurs. Current events surrounding academic freedom and freedom of speech on campus are being monitored by national advocacy groups. Individuals may consider reaching out the AAUP, which provides resources to its members including representation in negotiations with employers and referrals to legal services. <sup>14</sup> The ACLU and the FIRE both provide public-advocacy legal services for free speech issues. <sup>15</sup>

## **Next Steps**

It is hoped that this tenuous free-speech environment will not last and that deeper principles of open debate and deliberation re-emerge. In the meantime, the FEAF Committee plans to continue monitoring and discussing this situation and considering further action.

The committee will also continue to defend the rights of faculty, staff, and students to engage with matters of public concern as they participate in political mobilizing and fundraising, public speaking and publishing, and membership in lobbying and advocacy organizations.

We also remind members of the campus community that we are a forum for expressing and deliberating over specific concerns on campus and encourage them to speak with committee members about free speech and academic freedom issues.
